- No previous convictions or entries in the certificate of good conduct
- Natural scientific knowledge
- High sense of responsibility
- ability to work in a team
- Communication strength
- Technical and IT know-how
- Fast responsiveness and accuracy
- Excellent health and physical fitness
- Passed entrance exam/aptitude test
- Successful credit check (financing possible)

Tasks of the study agency ADIL

- Cooperation partner for foreign partners and agencies including their cost clarification
- Support in obtaining visas (APS requirement)
- Support with the necessary recognition periods of previous academic degrees
- Pre-check of all notarised documents (Abitur certificates, English language certificates, police clearance certificates, previous degrees, etc.)
- Entrance examination (mathematics, physics, English as well as general and preliminary health examination)
- Selection decision on participation in this special programme
- Certified translations by a court-approved interpreter in Germany
- Procurement of the necessary pre-admissions for APS special programmes
- Support in the application process up to enrolment at the German higher education institution
- Approval for this special programme up to the signing of the study contract with the German higher education institution
- Approval for this special programme until the training contract with the flight school has been signed.
- Low-cost accommodation and introduction to the German way of life
